## Tire allotment

1 new Hoosier 790 may be used for this event. 3 used Hoosier 790 must be used. Or DOT equivalent  
Same tires must be used for Qualifying, Heats/Dashes, Last Chance and Feature events.

---

## Qualifying Procedure

Group qualifying will be used for this event. Faster lap will determine starting position for heats and dash events. Adjustments or repairs may not be made to the car after it has entered the racing surface. Cars not in number order may lose a qualifying lap.

Fastest 12 from qualifying will transfer to the feature. These will run 6 lap Odd/Even dashes.

Inverted by dice roll plus 6. Second feature start will be top 12 from finish order inverted by dice roll plus 6

Rest of the field will run qualifying heat race(s). Transfer to be determined by total car count.

Cars not transferring through Qualifying or heat races will run a Last Chance race. Lined up by finish order of heat races .Number transferring will depend on car count.

Provisional positions will start 23 and 24. Position 23 top 15 in 2018 MWD points not already in the feature. Position 24 will be top 15 in 2018 State Park Speedway points not already qualified for the feature.

## Race Procedures

All car involved in a caution will fall to the tail of the field.

The last completed lap will be used for all relines.

MWD will use a lane cone for last chance and feature restarts. Leaders side by sidet. All other cars may choose a lane, double file behind the leaders. Lapped cars and cars involved on the caution may not participate in the caution. Must start at the tail of the longest line. Lapped cars behind lead lap cars.

**Race Control Frequency: 454.000 \*\*\*No Two-way radios will be allowed\*\*\* All competitors are required to use a scanner or Receiver anytime on the Speedway.**

**Transponders will be used for this event.**

## Special Rules

This event is run in accordance with 2018 MWD Series rules, the provisions of this Official Entry Blank, any special rules applicable to the event and any amendments thereto. In the event of any conflict between the MWD Series Rules 2018, the Official Entry Blank and the special rules, MWD's determination as to the interpretation and application of the conflicting rules will be final.

Note: All engine fluids, lubricants, solvents and fuels must be disposed of in a proper manner in accordance with track rules and procedures.

## Logos and Decals

Failure to display MWD series decals may result in loss of 1 or more qualifying laps. Driver must cooperate with MWD Officials in Victory lane ceremonies if requested.
