## Qualifying Procedure

Competitors will be given 2 laps. Faster lap will determine starting position for heats and dash events. Adjustments or repairs may not be made to the car after it has entered the racing surface.

Heat races will be lined up based on qualifying time.

Feature lineup inverted by dice roll plus 6.

Cars not transferring through Qualifying or heat races will run a Last Chance race. Lined up by qualifying time. Number transferring will depend on car count.

Provisional will start 24.

## Race Procedures

All car involved in a caution will fall to the tail of the field.

The last completed lap will be used for all relines.

Mid-American will use a lane cone for last chance and feature restarts. Double file front row. All other cars may choose a lane, double file behind the leaders. Lapped cars and cars involved on the caution may not participate in the caution. Must start at the tail of the longest line. Lapped cars behind lead lap cars. Cone will be used a maximum of 5 times. No cone with less than 5 laps to go.

**Race Control Frequency: 454.000 \*\*\*Two-way radios will be allowed\*\*\* All competitors are required to use a scanner or Receiver anytime on the Speedway.**

Transponders will be used for this event.

## Special Rules

This event is run in accordance with 2019 Mid-American Series rules, the provisions of this Official Entry Blank, any special rules applicable to the event and any amendments thereto. In the event of any conflict between the MASCS Series Rules, the Official Entry Blank and the special rules, MASCS's determination as to the interpretation and application of the conflicting rules will be final.

Note: All engine fluids, lubricants, solvents and fuels must be disposed of in a proper manner in accordance with track rules and procedures.

## Logos and Decals
